With reference to your letter dated 24.3.1979, I am to convey sanction for permanent affiliation of the above said school under the All-India Secondary School Course (classes IX & X) under 10+2 pattern of education w.e.f. 1.5.78 according to the syllabi/courses prescribed by the Board and also in the subjects of work-experiences in which the school already stands affiliated.

The sanction is subject to the fulfilment of the following conditions or conditions as may be laid down by the Board from time to time:-

1. The Reserve Fund of Rs. 12,400/= in the name of the Manager of the school be transferred into joint names of the Chairman, C.B.S.E. and the Manager of the school with immediate effect;
2. The original degrees of the following teachers be sent for verification:-

a) Ms. Grace C.D.	M.Sc.	degree.
b) Sh. V.N. Rao	B.Com.	degree.
c) Ms. G.V.S. Lalitha	B.Ed.	degree.
d) Sh. P. German Reddy	B.Sc.	degree.
3. Qualified P.T.I., Librarian and Drawing teacher be appointed and their full particulars be sent to this office by June, 1979;
4. As per recommendations made by the Inspection Committee which visited your school on 9.8.1978, the following deficiencies have been observed:-
  - a) A large part of the present teaching staff is not qualified for teaching classes-XI & XII;
  - b) The Science labs. have to be equipped with some more apparatus.
  - c) The expected number of students in class-XI be intimated.

You are requested to make good the above deficiencies and then apply afresh for upgradation as per prescribed form (copy enclosed).
